APPLICATION FOR REGISTRATION – NON foal recorded horses

FOAL RECORDED HORSES (PLEASE USE APPLICATION FOR ADULT UPGRADE FORM)

FOAL RECORDING (PLEASE USE APPLICATION FOR FOAL RECORDING FORM)

Foal recording is mandatory for:

- **ALL COLTS under 2 years of age, REGARDLESS OF PARENTAGE, COLOUR & REGISTER**
- **ALL PALOMINOS under 2 years of age**
- **ALL HORSES WITH UNKNOWN OR UNPROVEN PARENTAGE under 2 years of age REGARDLESS OF COLOUR & REGISTER**
- **ALL HORSES WITH ROAN, APPALOOSA or PALOUSE PARENTAGE under 2 years of age.** Horses with appaloosa / Palouse parentage will be issued with a temporary registration at 2 years of age & will be required to be reinspected after 4 years of age to ensure they are still free of characteristics.

DNA TESTING

- **All DNA results will be recorded on registration certificates.**
- All horses with **unknown parentage** are required to be DNA tested for all currently available coat colour pattern genes (OLWS, tobiano etc) & roan (dilutes only) before they will be eligible for registration.
- All **cremellos & perlinos with unknown parentage** are additionally required to be DNA'd for grey and roan and must return a negative result to be eligible for registration.
- All **cremellos & perlinos with grey or roan parentage** are required to be DNA'd for grey and/or roan as applicable and must return a negative result to be eligible for registration.
- Any horse with **combination dilute parentage** (ie cream / silver) may be required to be DNA tested for all dilutions carried by the parents to determine correct genetic colouring UNLESS one parent is a proven homozygote for a particular dilution.
- Solid dilutes with **registered paint / pinto parentage** that return a **NEGATIVE** DNA test for **OLWS** (lethal white) and **tobiano** will be accepted for studbook registration. Solid dilutes with paint / pinto parentage found to be carrying OLWS and/or tobiano OR for which no DNA testing is done will only be eligible for non-studbook registration.
- All horses being presented for registration as **black or brown buckskins** are required to undergo DNA testing for the Cream factor UNLESS it can be **PROVEN** by parentage or progeny that they carry cream ie double dilute parent, double dilute offspring or single dilute offspring from a **PROVEN NON-DILUTE** partner. They may also be required to be DNA'd for agouti to determine black or brown base colour.
- Horses being presented for **dun** registration that exhibit primitive markings which in the opinion of the registrar are not consistent with those found on true genetic duns will be required to undergo a dun zygosity DNA test.
- Horses being presented for **silver** registration may be required to undergo DNA testing for agouti (to determine black or brown base colour), red factor (to determine chestnut or bay base colour) or silver at the discretion of the registrar.
- Horses being presented for **palomino** registration which have a silver parent will be required to be DNA tested for silver and if a positive test is returned, they will be registered as silvers and not as palominos.

PALOMINOS:

All palominos are foal recorded up until the age of 2 years, at which time they require classification for adult registration by accredited company classifiers.

Palominos carrying an Ancillary Registration are not eligible for permanent Ancillary Registration until 2 years of age. These Ancillaries are Foal Recorded and Adult Registered by classification.

ANCILLARY REGISTERS:

Dilutes eligible for Ancillary registration are subject to the appropriate regulations pertaining to their dilute registration.

Non-dilutes eligible for Ancillary registration may be EITHER Foal Recorded up until 2 years of age (use application for foal recording) OR permanently registered from birth.

REQUIRED PAPERWORK - ALL REGISTERS EXCEPT PALOMINOS

- **PHOTOS** showing front, rear, near side, off side, under belly (including testicles), both eyes, side view of teeth, close up of brands and under tail in mares showing vulva,

OR

- **VIDEO/DVD** showing same verifying acceptability and proof of colour.
(DUNS – close ups of dun characteristics also required.)
- **PROOF OF BREEDING** (if not previously foal recorded) FOR HORSES OF KNOWN PARENTAGE
- **PROOF OF OWNERSHIP** IF YOU ARE NOT THE BREEDER (copy of other breed rego certificate showing horse in your name, copy of authorised transfer, copy of receipt, statutory declaration)

REQUIRED PAPERWORK - PALOMINOS

- **APPLICATION FOR CLASSIFICATION** form
- **PHOTOS** showing front, rear, near side, off side, under belly (including testicles), both eyes, side view of teeth, close up of brands and under tail in mares showing vulva,, close up of fanned out mane & tail.

OR

- **VIDEO/DVD** showing same verifying acceptability and proof of colour.
- **PROOF OF BREEDING** (if not previously foal recorded) FOR HORSES OF KNOWN PARENTAGE
- **PROOF OF OWNERSHIP** IF YOU ARE NOT THE BREEDER (copy of other breed rego certificate showing horse in your name, copy of authorised transfer, copy of receipt, statutory declaration)

Notwithstanding the above, any non-dilute Ancillary that exhibits signs of appaloosa, Palouse, paint or pinto coat colouration will not be eligible for registration.

CHECK LIST

Before lodging this form have you:

- Completed a membership application if you are NOT a member of Dilutes Australia OR
- Completed a membership renewal application if you are an UNFINANCIAL member of Dilutes Australia
- If horse is **microchipped**, provided a copy the microchip certificate OR if horse is **NOT BRANDED** provided a copy of another breed society registration certificate verifying **prior** unbranded registration

Please note that failure to provide verification of pedigree / parentage will result in your horse or pony being NON-STUDBOOK registered & it's pedigree listed as being 'NA'.

- Copy of service certificate or similar
- Copy of other breed society registration
- Statutory Declaration

VERIFICATION OF COLOUR:

Included the following items / documents

- Photographs or Video / DVD as listed on first page
- Copy of DNA results where required

PROOF OF LEGAL OWNERSHIP:

Included **ONE** of the following documents if you are NOT the breeder:

- Copy of other breed society registration showing horse in your name
- Copy of other breed society signed transfer – must be signed by the owner listed on the rego certificate
- Copy of receipt signed by the seller
- Statutory declaration stating you are the legal owner of the horse
- Copy of signed lease agreement or letter from the legal owner if you are in the process of paying off the horse OR if you have an official lease agreement

PAYMENT:

- Included a cheque, money order or copy of online deposit transaction for the **CORRECT** amount

Failure to provide any of the above will result in delays to the processing of your registration.

- NON-STUDBOOK REGISTRATION – may have unknown or unregistered parentage. **Paint / pinto parentage** if negative DNA results for OLWS & Tobiano not provided or if horse is not tested.
- ANCILLARY REGISTRATION – must be the progeny of a Dilutes Australia **STUDBOOK** registered sire or dam.
- FOUNDATION MARE REGISTRATION – solid, non-dilute mare having produced a REGISTERABLE DILUTE foal

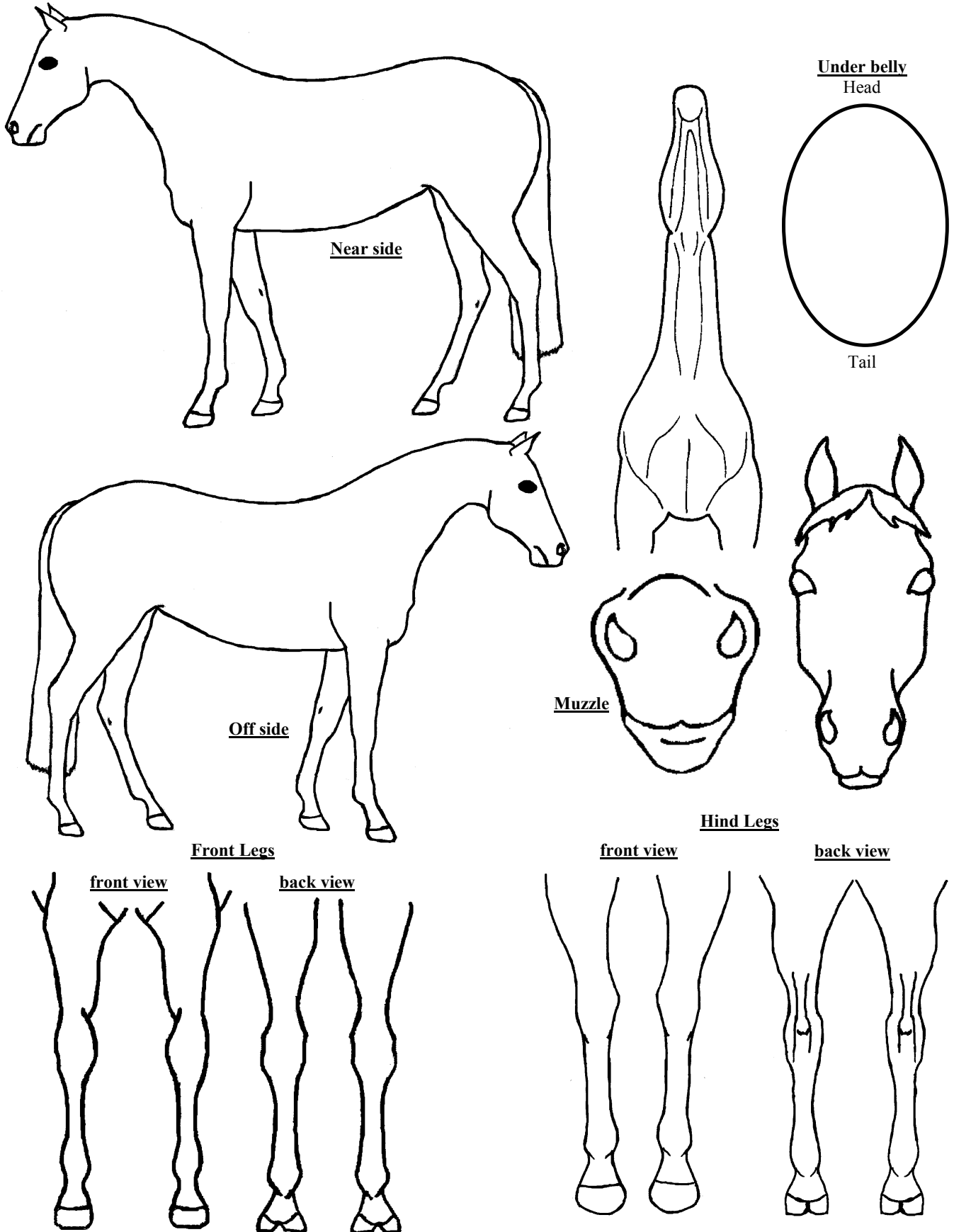
